If the Candidate completed a survey, a grade was assessed based on the Candidate's answers (partial credit was awarded for any answer, a decline-to-answer was given 1 point.)

The traditional academic scale was used to assign a letter grade.

A > 90%, B: > 80%, C: > 70%; D: > 60%; F: > 0%
